As such, Solactive will only review the benchmark's definition and methodology on an ad hoc basis and not on a periodic basis, such as the "at least annually" period proposed in the BMR.</p> |

Due to the high calculation frequency of intraday values, it is not possible to verify the input data used in each case. The implementation of procedures to allow for such intraday verification would not be appropriate and would make it impossible to continue to calculate the benchmark in the current frequency. In addition, financial instruments, financial contracts and investment funds that reference the benchmark generally use the end-of-day value of the benchmark to determine the values derived from the benchmark.</p> <p>For input data based on end-of-day values for the assets underlying the benchmark, Solactive has a procedure in place to verify such input data.</p> <p>Spot foreign exchange rates used for conversions of prices and values of components of the benchmark quoted in a currency other than the currency of the benchmark cannot be verified due to the lack of alternative available sources. Furthermore, the transparency of these exchange rates, which is achieved through their publication, has the effect of verification through existing market mechanisms.</p> |
