Additionally, companies are excluded if field 231112111799 is 'Non-Compliant' and field 261111143799 is 'NULL, Disengage, or Evaluate', or if field 231112111799 is 'Non-Compliant', field 261111143799 is 'Engage', and field 261111213799 is 'Low'.</li> <li>&gt; Remove companies with any detectable involvement in the core weapon system, or components/services of the core weapon system that are considered tailor-made and essential for the lethal use of the weapon. Additionally, if the field ID 211115122999 is assigned 'NW1' and either 211115231699 or 211115261699 is set to 'Not a signatory,' the company is excluded.</li> </ul> |
