<b>List of environmental factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies with negative impact of the company operation, according to international norms and principles; in particular the 10 UN Global Compact Principles.</li><li>&gt; Exclusion of companies with &gt;5% involvement in thermal coal power generation or mining.</li><li>&gt; Exclusion of companies with &gt;5% involvement in the generation of nuclear power or in supporting products/services.</li><li>&gt; Exclusion of companies with any involvement in hydraulic fracturing.</li><li>&gt; Exclusion of companies with any involvement in the production or exploration of oil sands.</li></ul>
<b>List of social factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies with negative impact of the company operation, according to international norms and principles; in particular the 10 UN Global Compact Principles.</li><li>&gt; Exclusion of companies with verified ongoing involvement in the area of controversial weapons.</li><li>&gt; Exclusion of companies with &gt;5% involvement in the sector of military contracting.</li><li>&gt; Exclusion of companies with &gt;5% involvement in the production or distribution of pornography.</li><li>&gt; Exclusion of companies with &gt;5% involvement in the production, distribution, retail or related products/services of tobacco.</li><li>&gt; Exclusion of companies with &gt;5% involvement in the operation of gambling facilities or production of specialized equipment or supporting products/services for gambling.</li><li>&gt; Exclusion of companies with &gt;5% involvement in the production of alcohol (&gt;15% alcohol per volume).</li></ul>
