The FWPL comprises companies which are (1) involved in the manufacture of controversial weapons (2) persistent violators of the UN Global Compact and/or (3) pure coal mining companies. It is reconstituted by LGIM on a semi-annual basis in March and September. > Weighting the securities by incorporating the L&G ESG Score as well as committing to a carbon reduction trajectory.

The FWPL comprises companies which are (1) involved in the manufacture of controversial weapons (2) persistent violators of the UN Global Compact and/or (3) pure coal mining companies. It is reconstituted by LGIM on a semi-annual basis in March and September. > Exclusion of companies with revenues (in proportion to total revenues) > 5% from assault weapons > Exclusion of companies with revenues (in proportion to total revenues) > 10% from military weapon system manufacturing > Exclusion of companies with revenues (in proportion to total revenues) > 10% from the production or retail of tobacco products and related services > Weighting the securities by incorporating the L&G ESG Score.
