The core normative framework consists of the Principles of the UN Global Compact.</li><li>&gt; Exclusion of companies involved in incidents and events that may pose a business or reputation risk to a company due to the potential impact on stakeholders or the environment. Companies are with a score of 4 or 5 (with 5 being the worst), are excluded.</li><li>&gt; Exclusion of companies generating revenues from the production or exploration of oil sands.</li><li>&gt; Exclusion of companies generating revenues &gt;5% from the extraction or power generation of thermal coal.</li><li>&gt; Exclusion of companies generating revenues &gt;0% from the production, distribution, or provision of products and services related to nuclear power.</li><li>&gt; Only companies in the bottom 20% in terms of ESG risk scores in each sector are allowed to enter the index.</li></ul>
<b>List of social factors considered</b>	<ul style="list-style-type: none"><li>&gt; Exclusion of companies with verified ongoing failure to respect established international norms. The core normative framework consists of the Principles of the UN Global Compact.</li><li>&gt; Exclusion of companies involved in incidents and events that may pose a business or reputation risk to a company due to the potential impact on stakeholders or the environment. Companies are with a score of 4 or 5 (with 5 being the worst), are excluded.</li><li>&gt; Exclusion of companies with verified ongoing involvement in the area of controversial weapons (including chemical, biological and nuclear weapons (both under and outside the Treaty on the Non-Proliferation of Nuclear Weapons), depleted uranium munitions, cluster munitions, and anti-personnel mines).</li><li>&gt; Exclusion of companies generating revenues (in proportion to their total</li></ul>
