The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises.> Exclusion of companies generating revenues (in proportion to their total revenues) >5% from coal mining or power generation from coal.> Exclusion of companies that are involved in the expansion of coal mining or coal power.> Exclusion of companies generating revenues (in proportion to their total revenues) >5% from services or >5% from distribution or >0% from production in the sector of tobacco.> Exclusion of companies generating revenues (in proportion to their total revenues) >5% from the production of oil sands.> Exclusion of companies generating revenues (in proportion to their total revenues) >5% arctic drilling.> Exclusion of companies generating revenues (in proportion to their total revenues) >5% hydraulic fracturing.> The top 75% of companies based on ESG score are selected.

The core normative framework consists of the Principles of the UN Global Compact and the OECD Guidelines for Multinational Enterprises.> Exclusion of companies with verified ongoing involvement in the area of controversial weapons (including chemical, biological and nuclear weapons (both under and outside the Treaty on the Non-Proliferation of Nuclear Weapons), depleted uranium munitions, cluster munitions, and anti-personnel mines).
