List of environmental factors considered	> Exclusion of companies generating revenues (in proportion to their total revenues) >1% from mining and liquefaction of coal. Exclusion of companies generating revenues (in proportion to their total revenues) >5% from power generation from coal. > Exclusion of any companies that fail to comply with the environment-related principles of the United Nations Global Compact.
List of social factors considered	> Exclusion of companies showing any involvement in production and trading of weapons, weapon systems, controversial weapons, i.e., nuclear, biological, and chemical weapons, cluster munitions, anti-personnel mines, and uranium ammunition. Exclusion of companies showing any involvement in production and/or provision of military equipment and services (combat involvement). Exclusion of any companies that are top arms-producers and military services companies in the world (SIPRI). Exclusion of companies generating revenues (in proportion to their total revenues) >5% in production and/or provision of military equipment and services (non-combat involvement). > Exclusion of any companies that fail to comply with the social-related principles of the United Nations Global Compact > Exclusion of companies showing any involvement in production of tobacco end products.
List of governance factors considered	> Exclusion of any companies that fail to comply with the governance-related principles of the United Nations Global Compact.
