List of environmental factors considered	<ul style="list-style-type: none">> Exclusion of companies with verified, very severe failure to respect established norms relative to Corruption and verified, severe and very severe failure to respect established norms relative to Environment, Human Rights and Labour Rights.> Exclusion of companies generating revenues (in proportion to their total revenues) $\geq 1\%$ from exploration, mining, extraction, distribution or refining of Coal or $> 5\%$ from Power Generation from Coal.> Exclusion of companies generating revenues (in proportion to their total revenues) $\geq 5\%$ from exploration, extraction, distribution or refining of Oil.> Exclusion of companies generating revenues (in proportion to their total revenues) $\geq 5\%$ from exploration, extraction, manufacturing or distribution of Gas.> Exclusion of companies generating revenues (in proportion to their total revenues) $\geq 50\%$ from Electric Power Generation from Fossil Fuel Sources.> Exclusion of companies generating revenues (in proportion to their total revenues) $\geq 50\%$ from fossil fuels.> Exclusion of companies generating revenues from the production or exploration of oil sands.
