<b>List of environmental factors considered</b>	<ul style="list-style-type: none"><li>&gt; The overall ESG score of a company is used in the selection of index components</li><li>&gt; Exclusion of companies with major involvement in nuclear-related activities (&gt;5% of revenues) and semi-nuclear activities (&gt;0% of revenues).</li><li>&gt; The carbon footprint of a company as well as its Energy Transition Score are used in the selection of index components.</li></ul>
<b>List of social factors considered</b>	<ul style="list-style-type: none"><li>&gt; The overall ESG score of a company is used in the selection of index components</li><li>&gt; Exclusion of companies with major involvement in tobacco (revenue &gt;0% from the production of core tobacco products or &gt;10% from the production of secondary tobacco products, or &gt;10% from the distribution of core tobacco products)</li><li>&gt; Exclusion of companies with major involvement in weapons (revenue &gt;0% in the area of controversial weapons, other offensive products, and dual use product/services, revenue &gt; 5% from defensive &amp; auxiliary military products, or revenues &gt; 1% from financing of controversial weapons)</li></ul>
<b>List of governance factors considered</b>	<ul style="list-style-type: none"><li>&gt; The overall ESG score of a company is used in the selection of index components</li></ul>
