

# EXPLANATION OF HOW KEY ELEMENTS OF THE BENCHMARK METHODOLOGY REFLECT ENVIRONMENTAL, SOCIAL, AND GOVERNANCE (ESG) FACTORS

<b>List of environmental factors considered</b>	<ul style="list-style-type: none"> <li>&gt; Exclusion of companies without carbon intensity data available within the last 24 months</li> <li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues) &gt;10% from thermal coal production, thermal coal supporting product, oil sands, deep-water drilling, or arctic offshore drilling</li> <li>&gt; Exclusion of companies from the industries 'precious metal' and 'coal'</li> <li>&gt; The Climate Score of a company is used in the selection of index components. The Climate Score is an overall Score based on the following six climate criteria: (i) carbon intensity, (ii) carbon intensity variation, (iii) R&amp;D intensity, (iv) commitment score, (v) production score, (vi) product score</li> </ul>
<b>List of social factors considered</b>	<ul style="list-style-type: none"> <li>&gt; Exclusion of companies generating revenues (in proportion to their total revenues) &gt;0% from the production of tobacco (includes significant ownership in another company that produces tobacco), from related products or services (includes significant ownership in another company that produces tobacco), &gt; 10% from retail distribution of tobacco (includes significant ownership in another company that engages in retail distribution of tobacco)</li> <li>&gt; Exclusion of companies with any involvement in the production of controversial weapons or with any significant ownership in companies involved in the production of controversial weapons</li> </ul>
