List of social factors considered	<ul style="list-style-type: none">> Exclusion of companies with major involvement in the tobacco, gambling, armament (civilian firearms and/or military) industry.> The RAFI ESG Index Series uses five signals to determine a company's overall ESG Score: Environmental (E), Social (S), Governance (G), Diversity (D), Financial Discipline (FD)> Among other selection steps, the index excludes the bottom 10% (by adjusted fundamental weight) of companies with the lowest E, S, and G score respectively.
List of governance factors considered	<ul style="list-style-type: none">> The RAFI ESG Index Series uses five signals to determine a company's overall ESG Score: Environmental (E), Social (S), Governance (G), Diversity (D), Financial Discipline (FD)> Among other selection steps, the index excludes the bottom 10% (by adjusted fundamental weight) of companies with the lowest Environmental, Social, and Governance score respectively.> Among other selection steps, the index excludes the bottom 10% (by adjusted fundamental weight) of companies with the lowest Diversity score.> Financial Discipline (FD) is based on financial metrics and provided by RAFI Indices.



> Index constituents' fundamental weights are tilted by their respective ESG Score. A higher ESG score increases the weighting of any constituent.

Data and Standards used

Data Input	The data used to construct the index is sourced externally from Institutional Shareholder Services (ISS ESG)
Verification and quality of data	The provider of ESG-related data input is selected by the Administrator based on an assessment of its existing processes in order to ensure the reliability and representativeness of the ESG-related data. The data provider has established processes in accordance with accepted and established market standards that ensure the permanent quality and reliability of the ESG-data provided.
