The strategy is implemented in Segregated/Managed Accounts and aims for a relative outperformance of its benchmark index.

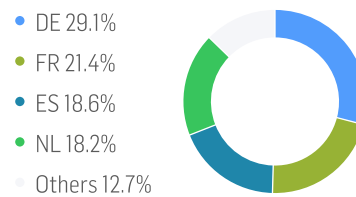
