It is weighted by free-float market capitalization and the number of constituents is floating.

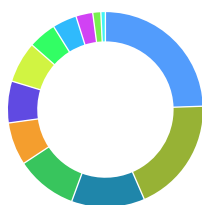

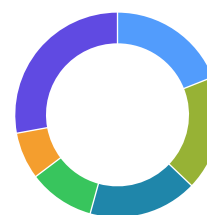
