

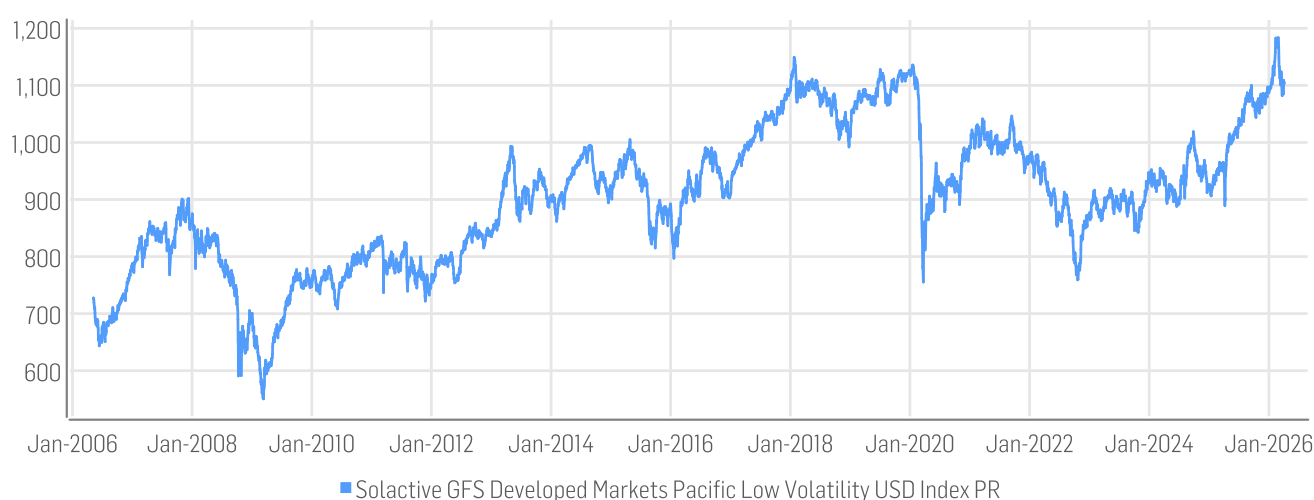
FACTSHEET - Solactive GFS Developed Markets Pacific Low Volatility USD Index PR AS OF 06-Apr-2026

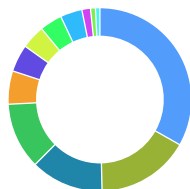

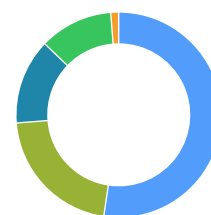
