DER AKTIONÄR Energiewende Index

DESCRIPTION

With solar, wind, biomass and hydrogen to a better climate

Climate change is one of the greatest global challenges facing the entire population. The consequences are already evident today. The number of natural disasters and extreme weather events such as storms, heavy rainfall and prolonged periods of drought have increased massively due to global warming. Scientists agree that CO2 emissions must be radically reduced. For this to succeed, alternative energy sources such as hydrogen, solar energy and energy generation from biomass and wind turbines must be increasingly used. The "DER AKTIONÄR Energiewende" index focuses on this trend. The index contains 10 globally active companies that declare war on CO2 emissions with their business areas. These include wind turbine manufacturers such as Vestas and offshore wind farm specialist Orsted, hydrogen manufacturers such as Air Liquide and Linde, solar park operators Encavis and companies such as Cropenergies and Verbio, which produce fuels from biomass.

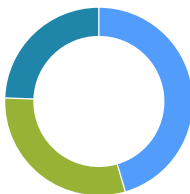

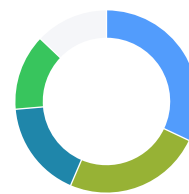
COMPOSITION BY CURRENCIES
