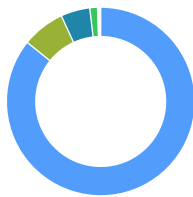

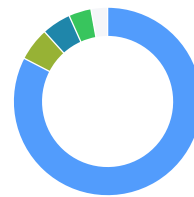
COMPOSITION BY CURRENCIES
