

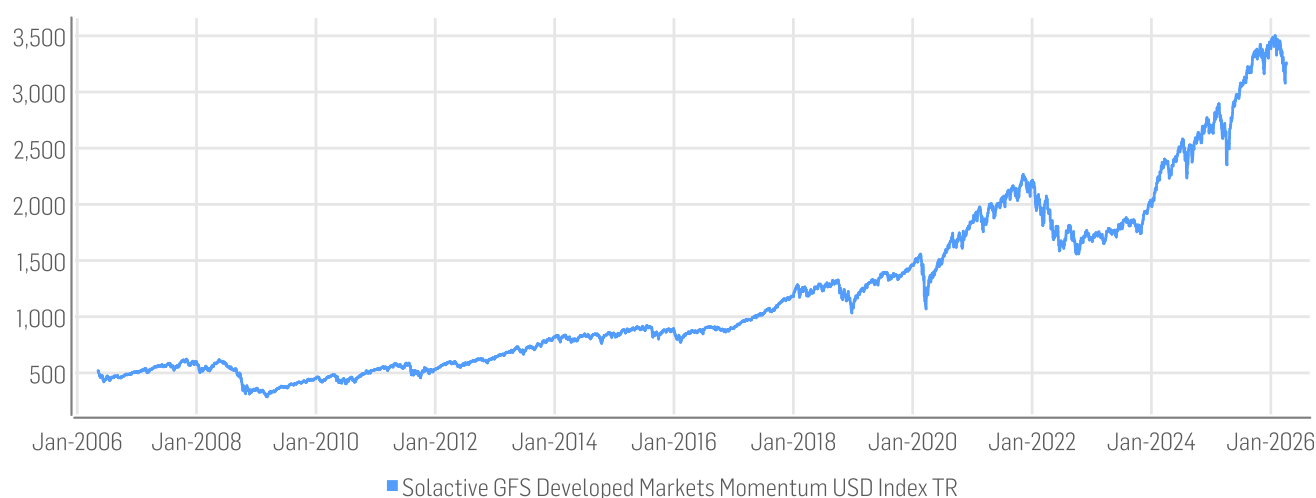
FACTSHEET - Solactive GFS Developed Markets Momentum USD Index TR AS OF 07-Apr-2026

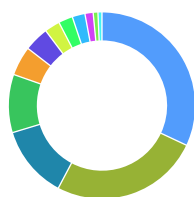

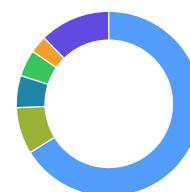
