DESCRIPTION

The Solactive GBS Developed Markets Nordic Large & Mid Cap EUR Index PR is part of the Solactive Global Benchmark Series which includes benchmark indices for developed and emerging market countries. The index intends to track the performance of the large and mid cap segment covering approximately the largest 85% of the free-float market capitalization in the Developed Markets Nordic. It is calculated as a price return index in EUR and weighted by free-float market capitalization.

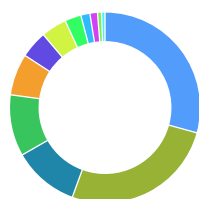

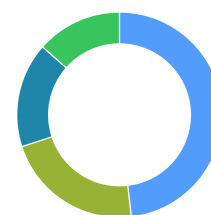
