

# Solactive Developed Markets ISS ESG SDG Climate Focus USD Index TR

## DESCRIPTION

The Solactive Developed Markets ISS ESG SDG Climate Focus USD Index TR aims to track the global stock market including only companies with an overall Significant or Limited Positive Impact on the Sustainable Development Goals and no Significant Negative Impact on any of the 17 single Sustainable Development Goals. In addition, companies need to operate in accordance with market standards for responsible business conduct. Those standards are based on established norms such as the United Nations Global Compact. Furthermore, companies involved in controversial weapons certain fossil fuel activities and military equipment are also excluded. The weight of all eligible securities is optimized in order to ensure the index' weighted overall SDG Score is at least 50% higher and its Carbon Intensity at least 50% lower than the benchmark. The index is calculated as a TR version in USD.

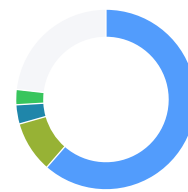
## COMPOSITION BY CURRENCIES
