DESCRIPTION

The Solactive GBS United States 400 + 600 Index intends to track the performance of the largest 501 to 1500 companies from the US stock market and is based on the Solactive Global Benchmark Series. Constituents are selected based on company market capitalization and weighted by free-float market capitalization. The index is calculated as a price return index in USD and reconstituted quarterly.

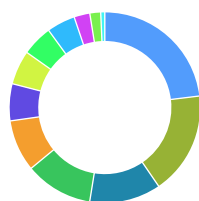
