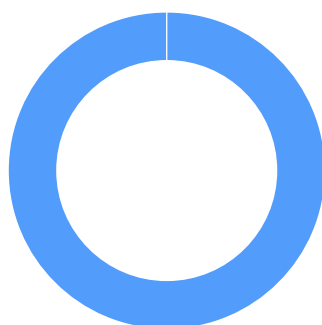

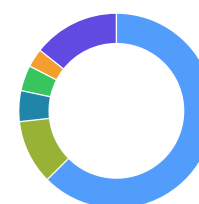
## COMPOSITION BY SECTORS
