DESCRIPTION

The index intends to track the performance of the investable universe covering approximately the largest 99% of the free-float market capitalization in the Developed Markets Europe ex United Kingdom. It is calculated as a price return index in EUR and weighted by free-float market capitalization.

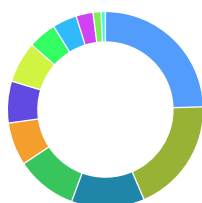

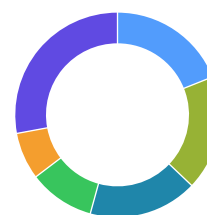
