

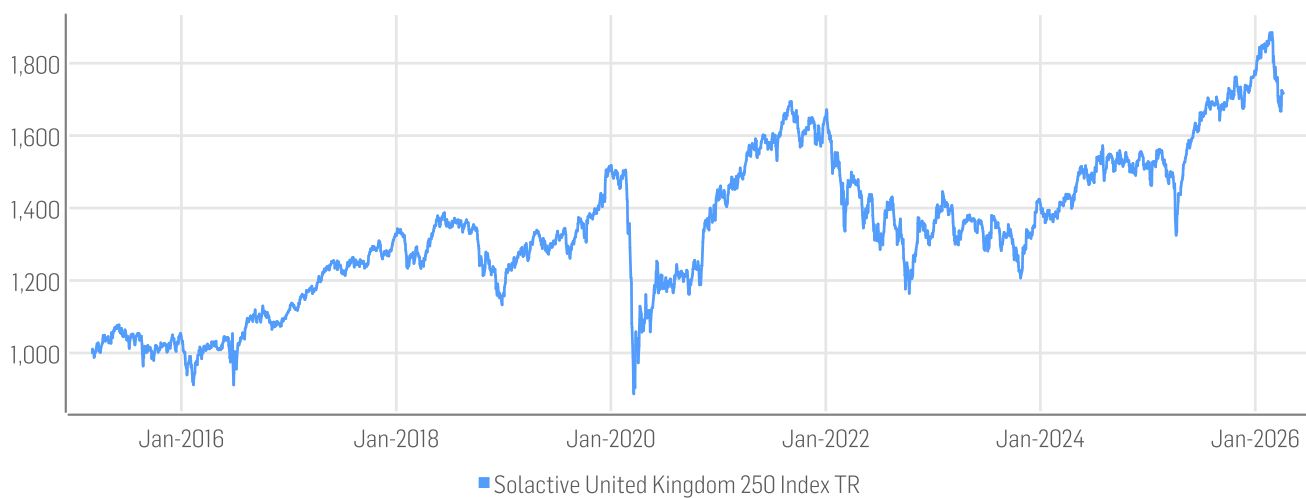

### DESCRIPTION

The Solactive United Kingdom 250 Index TR intends to track the performance of the largest 101 to 350 companies from the United Kingdom stock market. Constituents are selected based on full security market capitalization and weighted by free-float market capitalization. The index is calculated as a total return index in GBP and reconstituted quarterly.

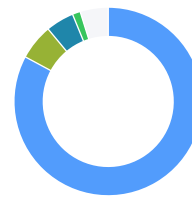
## COMPOSITION BY CURRENCIES
