

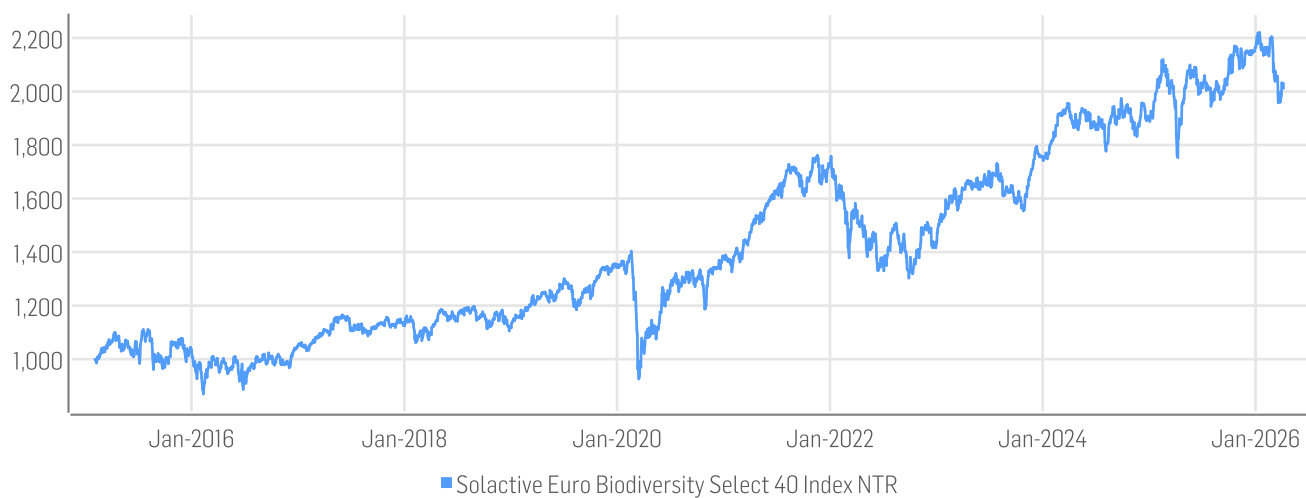

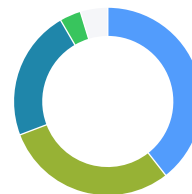
COMPOSITION BY CURRENCIES
