### DESCRIPTION

The index intends to track the performance of the investable universe covering approximately the largest 99% of the free-float market capitalization in the Developed Markets EMEA. It is calculated as a net total return index in EUR and weighted by free-float market capitalization.

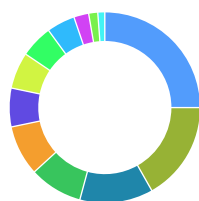

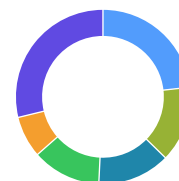
