

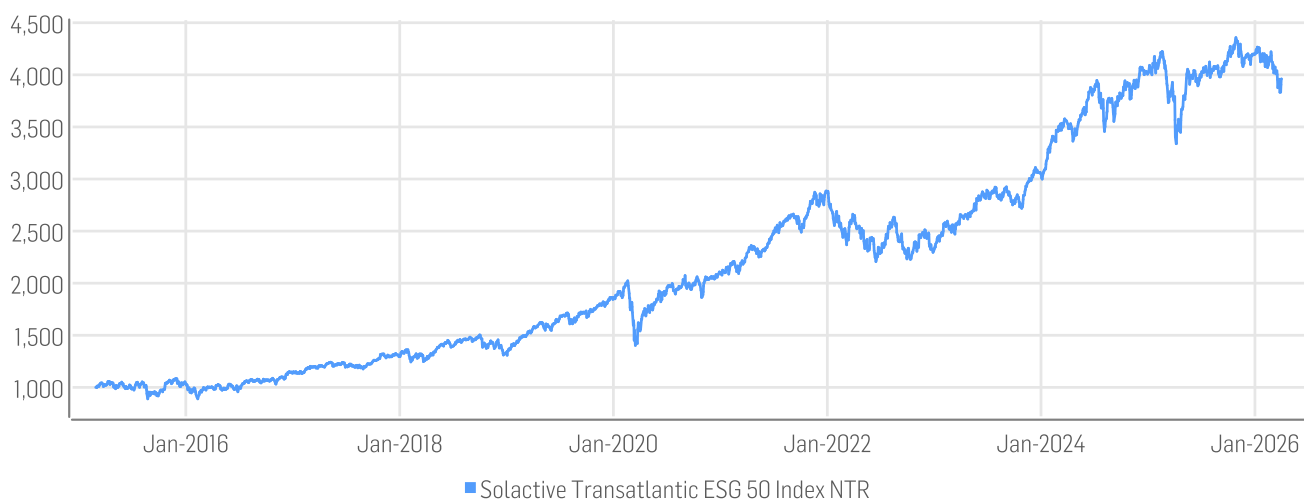

The index is calculated as a Net Total Return Index in EUR.

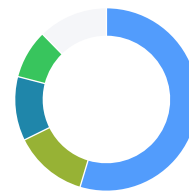
COMPOSITION BY CURRENCIES
