

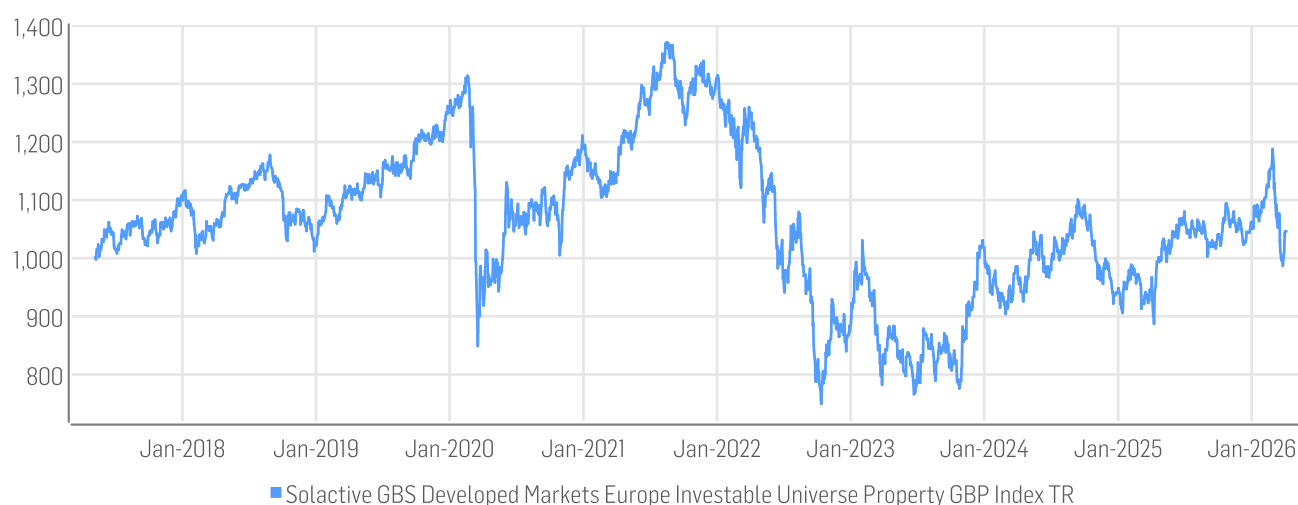
# FACTSHEET - Solactive GBS Developed Markets Europe Investable Universe Property GBP Index TR AS OF 06-Apr-2026

Constituents are weighted on the free-float market capitalization. The index is calculated as a total return index in GBP and reconstituted quarterly.

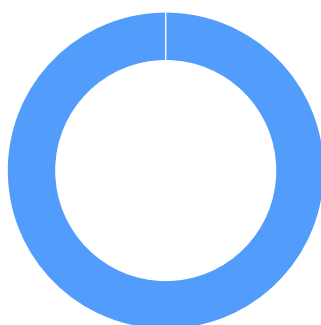

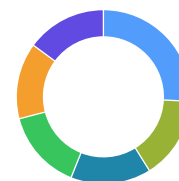
## COMPOSITION BY SECTORS
