The Solactive Australia 100 ex 50 USD Index PR intends to track the performance of the largest 51 to 100 companies from the Australian Securities Exchange. Constituents are selected and weighted based on free-float market capitalization. The index is calculated as a price return index in USD and reconstituted quarterly.

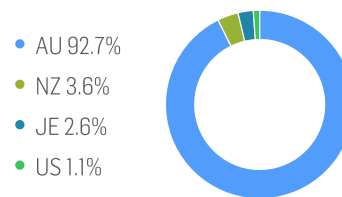
