The Solactive Australia 200 ex 50 EUR Index PR intends to track the performance of the largest 51 to 200 companies from the Australian Securities Exchange. Constituents are selected and weighted based on free-float market capitalization. The index is calculated as a price return index in EUR and reconstituted quarterly.

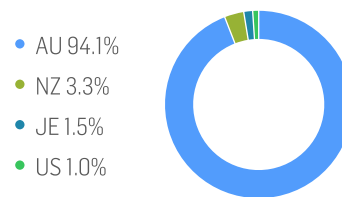
