The Solactive Australia 100 REIT USD Index NTR intends to track the performance of real estate companies from the Solactive Australia 100 Index. All constituents need to be classified as Real Estate Investment Trusts and weighted based on free-float market capitalization. The index is calculated as a net total return index in USD and reconstituted quarterly.

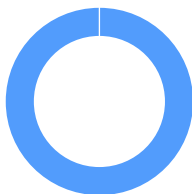

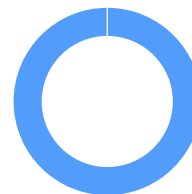
COMPOSITION BY CURRENCIES
