DESCRIPTION

The Solactive GBS Developed Markets Pacific ex Japan Mid & Small Cap USD Index NTR is part of the Solactive Global Benchmark Series which includes benchmark indices for developed and emerging market countries. The index intends to track the performance of the mid and small cap segment covering approximately the largest 70-99% of the free-float market capitalization in the Developed Markets Pacific ex Japan. It is calculated as a net total return index in USD and weighted by free-float market capitalization.

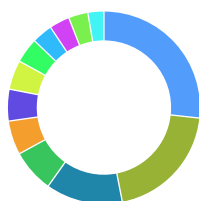

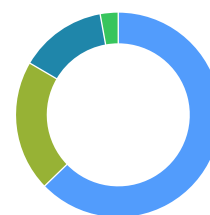
