### DESCRIPTION

The index intends to track the performance of the mid cap segment covering approximately the largest 70-85% of the free-float market capitalization in the Developed Markets Europe. It is calculated as a net total return index in EUR and weighted by free-float market capitalization.

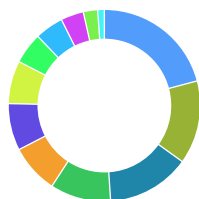
