The index intends to track the performance of the large and mid cap segment covering approximately the largest 85% of the free-float market capitalization in the Developed Markets EMEA. It is calculated as a total return index in USD and weighted by free-float market capitalization.

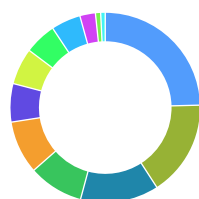

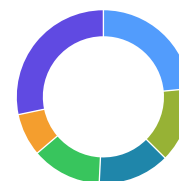
