

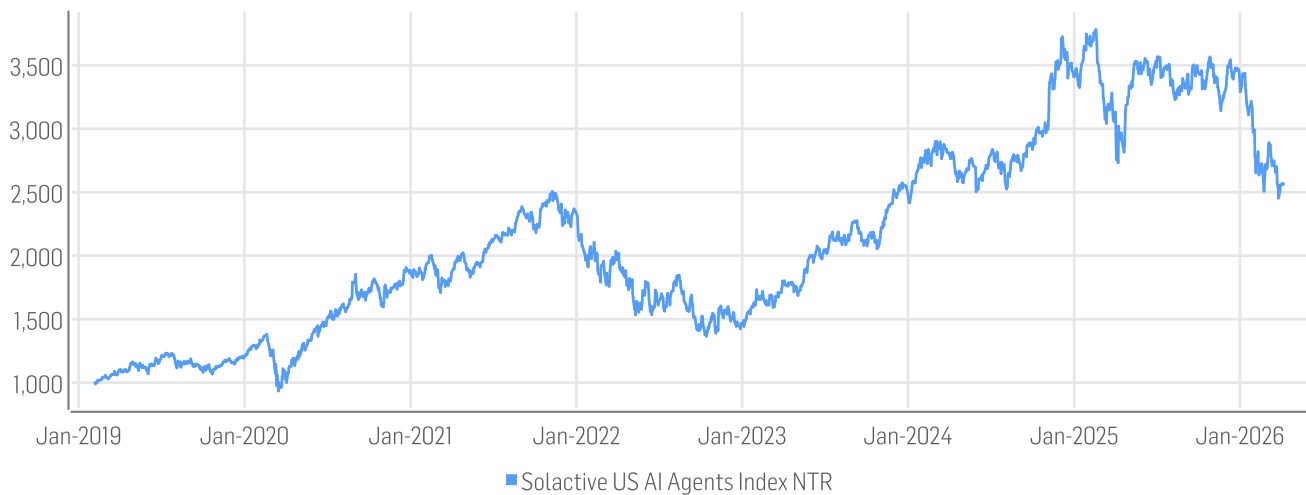

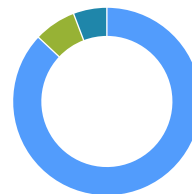
## COMPOSITION BY CURRENCIES
