

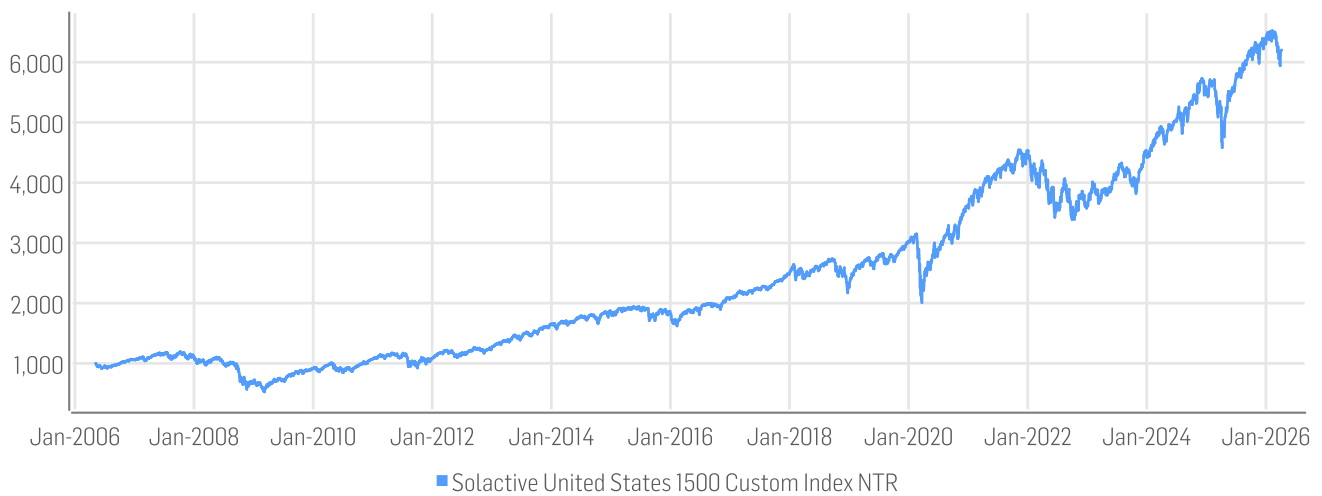

## Solactive United States 1500 Custom Index NTR

### DESCRIPTION

The Solactive United States 1500 Custom Index NTR intends to track the performance of the largest 1500 companies from the US stock market and is based on the Solactive Global Benchmark Series. Constituents are daily reweighted based on their size bucket assignment: 70% for large cap, 20% for mid cap, and 10% for small cap. The index is calculated as a net total return index in USD.

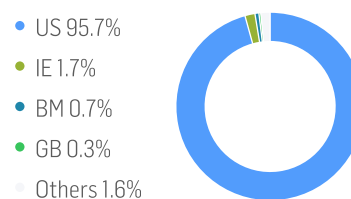
