

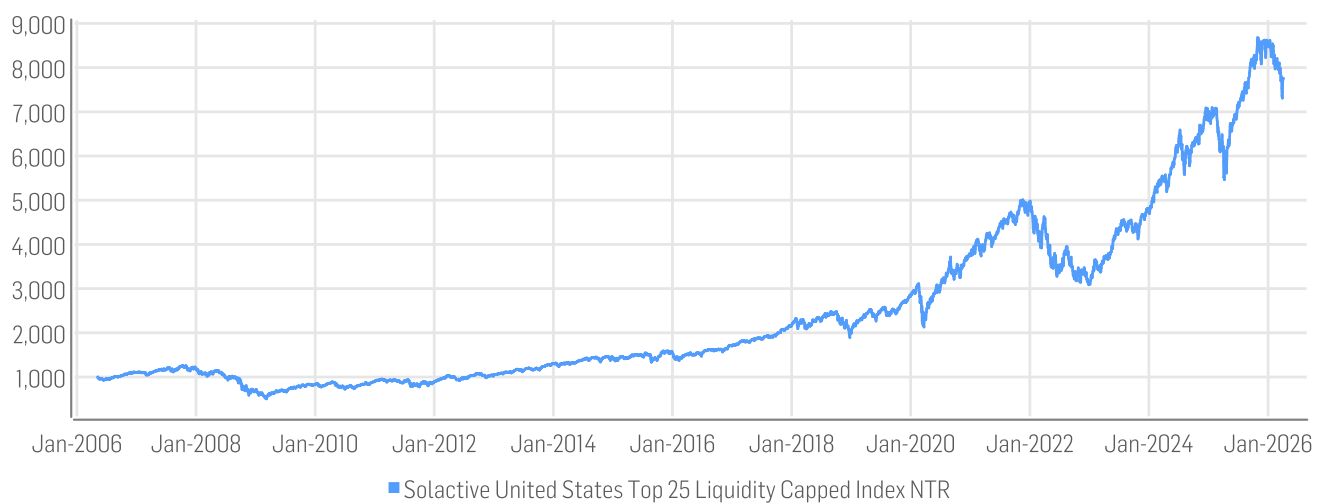

## Solactive United States Top 25 Liquidity Capped Index NTR

### DESCRIPTION

The Solactive United States Top 25 Liquidity Capped Index NTR intends to track the performance of the 25 most traded securities from the United States stock market. It is calculated as a net total return index in USD and reconstituted quarterly. Constituents are weighted based on free-float market capitalization subject to a 10% security capping.
