

Solactive Core Developed Markets Europe ex UK Large & Mid Cap EUR Index PR

DESCRIPTION

The Solactive Core Developed Markets Europe ex UK Large & Mid Cap EUR Index PR is part of the Solactive Core Index Family which includes benchmark indices for developed and emerging market countries. The index is derived from the corresponding Solactive Global Benchmark Series index and tracks the performance of the large and mid cap segment covering approximately the largest 85% of the free-float market capitalization in the European market. At the same time, it seeks to exclude companies which are (1) involved in the manufacture of controversial weapons (2) persistent violators of the UN Global Compact and/or (3) pure coal mining companies, such exclusions which are determined by reference to the "Future World Protection List" published by Legal & General Investment Management Limited. The index is calculated as a Price Return index in EUR and weighted by free-float market capitalization.

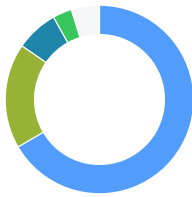
