It is calculated as a price return index in USD and weighted by free-float market capitalization.

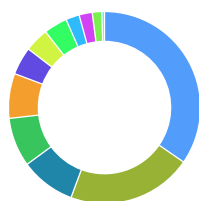

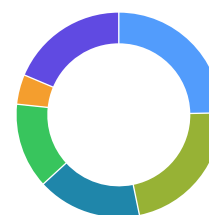
